



WAIVER OF ALL CLAIMS, RELEASE FROM LIABILITY AND ASSUMPTION OF RISK

I, _____, skipper or owner of the yacht _____, hereby acknowledge and agree that in my participation in the Aramex Dubai to Muscat Offshore Sailing Race (the “D2M” or the “Event”) on the 4th – 11th February 2023:

1. I will not hold Dubai Offshore Sailing Club (DOSC), its officers, directors and employees responsible for any injury, death, accident, illness, delay, personal loss, personal property damage or other loss sustained by me and hereby release DOSC, its officers, directors and employees due to any cause whatsoever, including without limitation, negligence on the part of DOSC or its employees.
2. By taking part in the event, each competitor agrees and acknowledges that:
 - (a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves whilst taking part in the event.
 - (b) The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities.
 - (c) It is their responsibility to familiarize themselves with any risks specific to the racecourse used during this event and to the rules and information produced for the venue or event and to attend any safety briefing held for the event.
3. I understand the nature of Aramex Dubai to Muscat Offshore Sailing Race and that me and my crew are qualified, in good health, and in proper physical condition to participate in such event. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the event.
4. I will participate in the D2M at my own risk. Participation in any outdoor activity and travel in natural, outdoor environments involve inherent risks, dangers, and hazards.
5. That this Waiver of all Claims, Release from Liability and Assumption of Risk is binding on myself, my heirs, my executors, administrators, personal representatives, and assigns.
6. That the term “Event” as used in the Waiver of all Claims, Release from Liability and Assumption of Risk includes without limiting the generality of that term, training sessions, programmes and events that are in any way authorized, sanctioned, organized or operated by DOSC.
7. I understand that by signing this release I may be forever prevented from suing or otherwise claiming against DOSC, its officers, directors and employees for certain loss or damages, whether for property loss or personal injury, that I may sustain while participating in the event.
