#### 1. Rules

- 1.1. The event will be governed by the rules as defined in the *Racing Rules of Sailing (RRS)*.
- 1.2. RRS Appendix T, Arbitration will apply.
- 1.3. The SB20 class rules will apply with changes under RRS 87 described in Appendix A.
- 1.4. In the event of a conflict between documents, the Sailing Instructions will prevail. This changes RRS 63.7
- 1.5. The Race Committee may stop a boat launching, or require it to return ashore, if they decide that a boat, its equipment and/or helm are not adequate for the likely conditions.
- 1.6. Each boat must carry an alternative means of propulsions in the form of an engine or two paddles.
- 1.7. [NP] Competitors should note that the Organizing Authority (OA) implements the RYA Racing Charter and that they will be expected to sail in compliance with it.

#### 2. Eligibility and Entry

- 2.1. Entries shall be made on the day via the sign on form available at Dubai Offshore Sailing Club (DOSC).
- 2.2. Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$1,000,000 or the equivalent and shall cover racing.
- 2.3. The event is open to the following boats:

- 2.4. When the number of boats entered is below the minimum on a particular race day racing will be cancelled and the day may not reschedule.
- 2.5. All boats will race with a unique sail number approved by SB20 UAE Class Association clearly visible on both sides of the main sail.
- 2.6. This event is only open to one design Sb20s. The Organizing Authority (OA) reserves the right to refuse any entry based on the type of boat not being suitable for the event.
- 2.7. Boats entering races at DOSC which is not owned by current members will be subject to an entry fee of AED 300 for each day's racing. Double SB20 racing days will be a total cost of AED 400. This entry fee includes berthing, launch and recovery. Entry fees are to be paid at the reception prior to signing on for racing. Boats that fail to pay this entry fee will not be included in the results and deemed not to have entered the day's racing.

- 3.2. Not more than 4 races per day will be sailed.
- 3.3. All races count towards the AGMC SB20 Commodore Cup Series
- 3.4. The Race Committee can request measurement or inspection at any time.

### 4. Sailing Instructions

- 4.1. The Sailing Instructions will normally be available at the Club and on the website one week before the first race.

### 5. Venue and Course Area

- 5.1. The venue will be the Dubai Offshore Sailing Club (DOSC)
- 5.2. The Start line will be within 2 miles of DOSC.

### 6. Courses





6.1. Courses will be detailed in the Sailing Instructions.

## 7. Penalty System

7.1. The Sailing Instructions will specify any changes to RRS 44 and if RRS Appendix P applies.

7.2. For breaches of any rule, other than a rule of RRS Parts 1 and 2, the Protest Committee may decide the penalty may be less than DSQ.

## 8. Scoring

8.1. The minimum number of races to constitute the AGMC Commodores Cup SB20 One Design Series is 3 races.

8.2. There shall be 1 discard for every 5 races sailed.

## 9. Prizes

9.1. Prizes will be specified in the event Sailing Instructions

## 10. Risk Statement

10.1. Rule 3 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone." Sailing is by its nature unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledge that:

- a. They are aware if the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event.
- b. They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore.
- c. They accept any responsibility for any injury, damage or loss to the extent caused by their own actions or omissions.
- d. Their boat is in good order, equipped to sail in the event and they are fit to participate.
- e. The provision of the race management team, patrol boats and other officials and volunteers by the event organizer does not relieve them of their own responsibilities.
- f. The provision of patrol boat cover is limited to such assistance particularly in extreme weather conditions, as can be practically provided in the circumstances.
- g. It is their responsibility to familiarize themselves with any risk specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event.
- h. They are responsible for ensuring that their boat is equipped and seaworthy to be able to face extremes of weather; that there is a crew sufficient in number, experience and fitness to withstand such weather; and that the safety equipment is properly maintained, stowed and in date and is familiar to the crew.

## 11. Advertising

11.1. Boats shall be required to display advertising or identification numbers chosen and supplied by the Organization Authority (OA). The OA reserves the rights to the first 20% of the hull length from the bow on both sides of the boat.

## 12. Inspections

12.1. The fact that the race officials may conduct inspections of a boat does not reduce the responsibilities of each competitor set out in this Notice of Race.

## 13. Support Boats





13.1. Support boats may be subject to restrictions that will be detailed in the Sailing Instructions

#### **14. User of Personal Data**

14.1. I, my crew and our support persons understand that the Organizing Authority (OA) will hold and use our personal data for the purpose of the event and the application of the rules. Further information can be found at [Club Data Policy](#)

14.2. DOSC and/or participating in DOSC-affiliated activities, whether on or off the official DOSC premises, I hereby grant DOSC, on behalf of myself, my family, including my child(ren), and/or my guests the irrevocable right and permission to photograph and/or record me, my family, my child(ren) and/or my guests and to use the photograph(s) and/or recording(s) for any purpose as determined by DOSC at its sole discretion. I waive any right to inspect or approve the use of the photograph(s) and/or recording(s), as well as any rights that I may have regarding the photograph(s) and/or recording(s) that may arise now, in the past or in the future. I acknowledge and agree that the rights granted in this release are without compensation.

#### **15. Amendments to the Notice of Race**

This Notice of Race may be changed by a notice posted on the official notice board (and duplicated on the Club Website)





## Appendix A - SB20 Class Rules Changes

SB20 class rules apply as available <https://www.sb20class.org/class-rules/> with the following changes.

1. Article C.4.1 point 1 is changed as follows.

*The boat shall be equipped with a personal flotation device for each crew member to the minimum standard ISO 12402-5 (Level 50), or USCG Type III, or AUS PFD 1 which **may be stored on deck or inside the main storage hatch provided they are easily reachable in the event of an emergency.***

2. Article C.5.1 Mandatory Equipment is deleted entirely and replaced with the wording:

*The following safety equipment shall be carried at all times:*

- a) *One floating throwing line, not less than 10m long and 6mm diameter.*
- b) *Two paddles of combined minimum weight not less than 1 kg.*
- c) *A functioning VHF radio or a functioning mobile phone used for emergency purposes only while racing*
- d) *First aid kit in waterproof container*
- e) *A knife or a multi-tool containing a knife*
